NOTICE INVITING TENDER

Inviting Companies/Agencies for bids for Rate Contracting of Beds for use in various hospitals of the State.

Procurement Requirement:- The State of Bihar has 533 Primary Health Centers, 76 First Referral Units , 22 Sub Divisional Hospitals & 27 District Hospitals. The combined bed strength of these hospitals is around 12000 beds. The State is also taking steps to increase the bed strength of these hospitals. It is expected that these bed strength is likely to double in next 5 years.

Beds are required for all increase in bed strength and also for replacing the existing beds.

Tender are invited from reputed Companies/Agencies for procurement of Beds for Labour Rooms in various hospitals of the State.

- **The Specification of Beds are enclosed as Annexure- I.**

Submission Requirements:- Interested Companies/Agencies wishing to undertake the above task may submit the tender in a large envelop marked "Tender bid for Rate Contracting of Beds for Labour Room". This large envelope will contain two separate sealed envelops- One for their Technical bid marked as **cover-A** and another for their Financial bid marked as **cover-B**.

You are requested to clearly indicate each of the submission requirements mentioned above in the cover letter/application accompanying the technical proposal. Each page of the Technical Proposal should be serially numbered. The cover letter should be accompanied with an item with index and page no. also.

Tender Condition/Minimum Eligibility Criteria:

- (1) Minimum warranty offered should be for 3 years. Higher warranty period shall be preferred.
- (2) The final price quoted should be inclusive of all taxes.
- (3) The items shall be installed at various hospitals of the State . Rates quoted should be inclusive of all transportation costs of taking the items/material to District for installation.
- (4) The rates finalized shall be valid for a period of 5 years.
- (5) Minimum turnover of the companies/agencies must be Rs. 1 Crore.

Submission of Technical Bid :

The companies/agencies should provide the following information regarding the firm in technical bid envelop:

- (1) Name and address of the company/agency.
- (2) Certificate of Sales Tax Registration.
- (3) Details of experience in the field of supply of these items/materials.
- (4) Annual Audited Report for the last 3 financial years.

Earnest Money:- Bidder will be required to deposit 25,000/- security/tender money (Refundable) in the firm of demand draft favouring Executive Director, State Health Society Bihar as EMD.

Financial Bid:

Printed sheet with a landed price/basic rate including Local Sales Tax/Vat, then rates for taxes applicable and then the final rate, the tenderer is strictly prohibited to change/alter specification in the printed sheet and the rate will be the criteria for determining the lowest quoted rate, henceforth known as the L1 rate.

Financial bid shall be given in the following format

Deadline for submission of Tender:

The bids in sealed envelope shall be submitted to the Executive Director, State Health Society, Bihar, Pariwar Kalayan Bhawan Sheikhpura, Patna on or before 24 May 2008. Bids received after this time, would not be entertained.

Opening of Bids:-The technical bids shall be opened on the 27 May, 2008 in the presence of bidders or their authorized representative who desire to be present, and would their after be evaluated. The financial bids of only those tenderers will be opened whose technical bid is found eligible by the committee. The State Health Society, Bihar reserves the right to reject any or all tender without assigning any reason thereof.

For information of the Bidders:- The awarded supplier has to ensure supply within the stipulated time period, or else suitable action shall be taken against them.

The selected company/firms will be immediately inform about the final award. In case the selected company declines to take-up the purchase orders henceforth directly from the districts, on the quoted and approved rates, it would be barred from applying for any tender from Government of Bihar for a period of 3 years from the date of award.
